

## Terms and conditions - CUMab

The online software tool known as “CUMab” (“**Software**”) is the property of the Weizmann Institute, and may be utilized by and on behalf of academic non-profit entities only, under the terms and conditions set forth below (“**Terms**”). The use of the Software shall be deemed acceptance of the Terms on behalf of the entity utilizing the Software.

1. The Software is owned by the Weizmann Institute of Science (“Institute”) or its technology transfer entity, Yeda Research & Development Company Ltd. (“Yeda”), a company incorporated in Israel.
2. The Software may be used by or on behalf of non-profit academic institutions only (“User”) for academic non-commercial research purposes only, excluding any and all commercial purposes whatsoever, which include, but are not limited to, collaborations with non-academic and/or commercial entities or activities sponsored by non-academic and/or commercial entities, and/or the assumption of any obligation or rights towards non-academic and/or commercial entities (“Non-Commercial Research Purposes”).

All results (not including data and sequences uploaded by User for the use of the Software) produced through the use of the Software by User (“Results”) shall be the sole property by the Institute and/or Yeda. User further agrees not to transfer the Results and/or grant any rights to the Results to any other person or entity, unless they have previously undertaken in writing to comply with the terms hereof. User agrees to use its best efforts and will take all reasonable steps to protect the Results from any unauthorized use, reproduction, publication, disclosure or distribution.
5. User will not use the Results in any human trials, military purposes, or in a manner contravening any laws.
6. User represents that it has obtained all approvals necessary under any applicable laws to the extent necessary for obtaining, storing, using, and uploading, all data being uploaded to or used in connection with the Software.
